



## Nuriootpa High School ICT Acceptable User Agreement

The use of Nuriootpa High School (NHS) Information and Communication Technologies (ICT) resources are governed by the Department of Education (DfE) and NHS ICT related policies. These policies are in place to protect NHS ICT assets from a range of threats including loss, corruption, disclosure, theft and interruption of services.

This user agreement applies to all students enrolled at NHS, who have computer access at the NHS site, and is to be read and signed by all users (including Parent/Caregiver) before they are given access to NHS ICT facilities.

**\*\*This signed form must be returned to the NHS Head of Technologies or IT Network Manager before access to the ICT Network is granted, and it will be retained for the duration that the student is enrolled at Nuriootpa High School.**

**IMPORTANT:** You must read and understand the documents and policies referenced in this User Agreement.

Users of NHS ICT facilities must:

1. Understand and adhere to the requirements of the "NHS Policy – ICT Cyber-Safety Use Agreement", which is published on the NHS website.
2. Use NHS ICT facilities in an appropriate and responsible manner according to the NHS ICT Policy documents published by the Technologies Coordinator.
3. Understand and adhere to the requirements of the "NHS Policy - BYOD/VDI Acceptable Use".
4. Follow the directions of NHS IT Support relating to their use of NHS ICT facilities.
5. Specifically, the access, transmission, retrieval, storage and/or display of:
  - Sexually explicit material;
  - Hate speech or offensive material;
  - Material regarding illicit drugs or violence;
  - Material regarding criminal skills and/or illegal activities;
  - Material of a defamatory, discriminatory or harassing nature;...is strictly forbidden if that material does not form part of a legitimate educational inquiry.

Violations of these policies, depending on severity and nature, may result in reprimand, loss of ICT access privileges, or any other appropriate disciplinary action.
